Include a description of the adequacy of health care and other services, supports, and assistance that developmental disabilities receive 1) in ICF(MR)s; and 2) through home and community-based waivers.(limit 4,000 characters):</b></p> <p>The Guam DD Council (Council) in the past year has made significant progress in automation efforts and in increasing collaboration with public and private partners. Collaboration: The Council and its two other Tri-agency partners, Center for Excellence in Developmental Disabilities Education, Research and Services and Guam Legal Services Corporation, continue to collaborate closely in advocacy, systems change, and capacity building efforts for island residents with developmental disabilities in accordance with the DD Act. The past year has also seen the Council work more closely with the Department of Integrated Services for Individuals with Disabilities (DISID). The DISID Director is now the agency representative in the Council for those services covered by the Rehabilitation Act. Two grant proposals that were submitted in the summer of 2005 by DISID, in partnership with the Council, resulted in one of those proposals being approved for the Aging and Disabilities Resource Center (ADRC) grant. With this grant, DISID and the Council are in the process of activating the Guam GetCare system, a community choice resource network that's aimed to improve the coordination of: (1) service delivery between multiple agencies that service target populations; (2) eligibility screening and determination to identify clients at risk of institutional placement and target them for additional follow-up; and (3) assistance with accessing private and public long-term care funds. With support from the Medicaid director, this project seeks to streamline the intake and submission procedures. The eligibility and intake process will be shortened by electronic transfer of information between agencies, service providers and eligibility administrators. Along with the Guam GetCare system, the ADRC grant also made it possible for the Council and DISID to develop each of their own websites that will also be activated January 2007. guamddc.com will not only serve as an information source and a link for our island consumers to access relative programs, information, and other agencies worldwide, it will also become the Council's own historical recording system. The Council has also established good working rapport with several members of the Governor's Cabinet and with Legislators, especially because of emphasis on compliance to requirements of a Permanent Injunction. This closer inter-agency relationship also helps to eliminate any potential barriers that may prevent the Council from accomplishing its State Plan goals and objectives. Strategic State Plan: The Council's new 5-Year State Plan (2007-2011) was submitted to the Administration on Developmental Disabilities (ADD) in August 2006 and its implementation was effective 10/1/2006. The Council met several times throughout the course of the past 18 months, and facilitated activities such as Policy Maker and Family Supports Forums and a Consumer Workshop, which gathered government officials with our service providers and consumers to discuss issues, raise concerns and make recommendations about Guam's support services delivery systems. The Council evaluated its activities over the past years and reviewed public input from these events, at which systemic problems were also indicated and potential areas of emphasis were identified. Following public input, a World Cafe? Model and two subsequent General Membership Working Sessions were also held, at which the Council identified more clearly where it should be headed in the next five years. The Council released the Draft State Plan for public comment from 6/21-8/4/06, from which comments were reviewed and incorporated as necessary into the state plan. The areas of emphasis and goals and objectives listed in the state plan are those which the Council will use to advocate and work towards helping improve Guam's support services delivery systems.
